Booking Terms and Conditions

- a. Bookings are tentative and will be held for 7 days without a deposit.
- b. Deposit is 25% of total up to a maximum of \$2,000, with Deposits being deducted from final invoice.
- c. Full payment, including bond is required 2 weeks prior to arrival, with deposits forfeited if cancellation within 2 weeks of arrival see Refund's below.
- d. For the bond to be refunded, dishes need to be washed, floors swept and mopped, and carpets vacuumed and no damage to buildings and furnishings. This includes inside chairs being used outside. **BYO camp chairs.**
- e. No Electric vehicle charging is available not in buildings or on powered sites min \$50 Fine payable.
- f. Any faults/damage/missing items must be reported to the Duty Warden immediately to avoid forfeit of bond.
- g. If staying in buildings no linen or toiletry items are supplied. BYO all bedding incl. pillows, towels and toiletry items.
- h. Prices charged will be those on the day of arrival and not at time of booking subject to a 10% maximum increase.
- i. Scout Groups NOT scouting families taking part in bona fide scouting activities will be charged at the current scout price. Please contact booking officer to obtain current price.
- j. Bookings for cabins over public holiday weekends, and also between the period 21st Dec to 6th Jan will be for a minimum of 2 nights.
- k. Equivalent of 1 wheelbarrow of wood will be supplied to cabins with wood fires per day of hire. Additional wood or wood for outdoor campfire may be purchased from camp warden.
- l. ALL WATER ON SITE comes from the rivers and needs to be boiled prior to consumption.
- m. Dogs must be on a lead or leash at all times and owners are responsible for cleaning up after them.
- n. Pets allowed to worry wildlife or cause a nuisance, will result in owners being asked to leave or remove their animal from site.
- o. Trail bikes in camping area are to obey vehicle rules at all times.
- p. Sites may be changed at Wardens discretion.
- a. FIRES
 - I. Fires are only to be lit in fire drums provided.
 - II. No bottles, glass or rubbish to be burnt.
 - III. Do not empty fire drums on ground if needed, see warden
 - IV. OBEY CFA RATING SIGNS AND CAMP MANAGER'S directions at all times Unattended fires will be extinguished.

- Low/Moderate: Fire permitted within Caringal regulations

- High: NO fires permitted where directed by Camp Manager

- Extreme: NO fires permitted, follow directions of Camp Warden. Be prepared to

evacuate

- Catastrophic: NO Guests on site.
